Assignment Of Patent Rights

This Assignment of Patent Rights (the "**Assignment**"), dated March 25, 2010 is between (i) Oxford Instruments Holdings, Inc. ("**OIH**"), a Delaware corporation, and (ii) Oxford Superconducting Technology Limited Partnership ("**OST**"), a Massachusetts Limited Partnership.

1. Definition of Patents. The term "**Patents**" means the U.S. patents and patent applications and PCT applications listed on the attached Schedule 1.

2. Assignment from OIH to OST. For good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, as of the Effective Date, OIH hereby sells, assigns, transfers and conveys to OST all of OIH's right, title and interest in and to the Patents. It is agreed and understood that OIH's assignment to OST includes OIH's right, title, and interest in and to (i) all patents and patent applications claiming benefit, in whole or in part, of any of the filing or priority dates of the Patents, including, but not limited to, extensions, divisionals, continuations, continuations-in-part, reissues, reexaminations, substitutions and foreign counterparts of any of the Patents; and (ii) all rights to causes of action and remedies related thereto (including, without limitation, the right to sue for past, present or future infringement of rights related to the foregoing).

3. Timing of Assignment. OIH states and confirms that this Assignment shall be effective as of the date and time immediately before the Assignment Of Patent Rights and Evidence of Transfer between (i) OST; (ii) Oxford Instruments America, Inc.; (iii) Oxford Instruments OST Holdings LLC; and (iv) Oxford Instruments OST Asset Co LLC (the "**Effective Date**").

4. Authorization. OIH authorizes OST to apply in all countries in OIH's name or in OST's own name for patents, utility models, design registrations and like rights of exclusion, and for inventors' certificates, relating to the Patents and the inventions disclosed therein; and OIH agrees for itself and its respective legal representatives and assigns, without further compensation to perform such lawful acts and to sign such further applications, assignments, Preliminary Statements and other lawful documents as OST may reasonably request to effectuate fully this Assignment.
