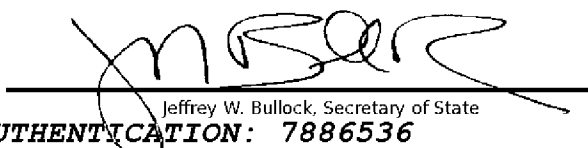

The undersigned, for purposes of amending the Third Amended and Restated Certificate of Incorporation (the "Certificate") of InSet Technologies Incorporated, a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware, does hereby certify as follows:

FIRST: The name of the Corporation is InSet Technologies Incorporated (the "Corporation").
