**AGREEMENT**

This Agreement is entered into on this 10 day of June 2010, by and between Mardela International, Inc., a Panamanian corporation, with U. S. address for intellectual property matters at 1020 N. Hollywood Way, Suite 152, Burbank, California 91505, United States of America, hereinafter "MARDELA"; and Ancor Tecmin S.A., a Chilean corporation, with business address at Avenida La Divisa 01011 – San Bernardo, Santiago, Chile, hereinafter "ANCOR TECMIN."

In consideration of the mutual promises set forth hereunder, the sufficiency of which is hereby acknowledged by the parties, they have agreed as follows:

MARDELA is the proprietor by assignment of U.S. Patent No. 6,143,219 issued November 7, 2000, entitled "METHOD AND APPARATUS FOR PRODUCING OCCLUSION-FREE AND VOID -FREE COMPOUNDS AND COMPOSITES," and U.S. Patent No. 6,730,195 issued May 4, 2004, entitled "ELECTROLYTIC CELL," and U.S. Patent No. 6,572,741 issued June 3, 2003, entitled "ELECTROLYTIC CELL," and Chilean Patent No. 43,921 issued November 12, 2009, and Chilean brand No. 735,572 named "SUPERTANK," and Chilean brand No. 509,198 named "Hyperbonded." MARDELA herewith authorizes ANCOR TECMIN the right to use, work, license or otherwise engage in business activity on the exclusive patent rights for the above-referenced United States Patents for ELECTROLYTIC CELL and in particular with reference to any business activity determined by ANCOR TECMIN in and for the People's Republic of China with the Chinese business concern known as "HEBEI ANCOR TECMIN KNT POLYMER CONCRETE CO., LTD." with business address at 124 Jinji Street, Jizhou City, Hebei Province, 053200, P. R. of China.


The parties to this agreement shall maintain the provisions in place until further notice in writing by the parties. Fifteen business days written notice shall be required from any of the two parties.


