therefor, in the United States and foreign countries and all reissues, extensions, renewals, divisions and continuations thereof, to the full end of the term or terms for which said Letters Patent may be issued, to be held and enjoyed by the said MITSUBISHI HEAVY INDUSTRIES COMPRESSOR CORPORATION , its successors and assigns the same as it would have been held and enjoyed by MITSUBISHI HEAVY INDUSTRIES, LTD., if this assignment and sale had not been made.

AND, MITSUBISHI HEAVY INDUSTRIES, LTD., hereby authorizes and requests the Commissioner of Patents and Trademarks to issue all such Letters Patents to the said MITSUBISHI HEAVY INDUSTRIES COMPRESSOR CORPORATION , in accordance with this instrument of assignment.

MITSUBISHI HEAVY INDUSTRIES, LTD., hereby represents and warrants that there are no rights or interests outstanding inconsistent with the rights and interests granted herein and that MITSUBISHI HEAVY INDUSTRIES, LTD., will not execute any instrument or grant or transfer any rights or interests inconsistent therewith, and MITSUBISHI HEAVY INDUSTRIES, LTD., binds itself and its heirs, executors, administrators, employees and legal representatives, as the case may be, to execute and deliver to the said MITSUBISHI HEAVY INDUSTRIES COMPRESSOR CORPORATION , its successors and assigns, any further documents or instruments and do any and all further acts that may be deemed necessary by the said MITSUBISHI HEAVY INDUSTRIES COMPRESSOR CORPORATION , its successors and assigns to file applications for the said improvements and invention in any country where it may elect to file such applications, and that may be necessary to vest in the said MITSUBISHI HEAVY INDUSTRIES COMPRESSOR CORPORATION , its successors and assigns, the title herein conveyed, or intended so to be, and to enable such title to be recorded in the United States and foreign countries where such application or applications may be filed.

improvements and the history thereof, known to it or its successors and assigns, and that it will testify as to the same in any interference or other proceeding when requested to do so by the said MITSUBISHI HEAVY INDUSTRIES COMPRESSOR CORPORATION, its successors and assigns.
