## ASSIGNMENT AND AGREEMENT

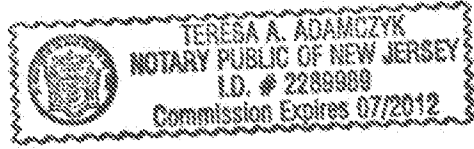
