Release of Security Interest in and Lien on Patents

NOW, THEREFORE, in exchange for good and valuable consideration, the receipt of which is hereby acknowledged, Agent does hereby release, relinquish and discharge its security interest in, to and under the Patents, and all products and proceeds thereof, including, without limitation, any claim by Grantor against third parties for past, present or future infringement of any Patent.
