ASSIGNMENT OF INVENTION

WHEREAS, We, MICHAEL A. DELLAVECCHIA and LARRY DONOSO residing in the City of Berwyn, County of Chester, Commonwealth of Pennsylvania; and the City of Philadelphia, County of Philadelphia, Commonwealth of Pennsylvania, respectively, have made a certain new and useful invention in a METHOD FOR OPTICALLY SCANNING OBJECTS and have filed an application for Letters Patent of the United States based thereon on May 15, 2008, and assigned Application Serial No. 12/121,038; and, together with the PHILADELPHIA RETINA ENDOWMENT FUND, also filed an international application under the Patent Cooperation Treaty based thereon on May 2, 2009, and assigned Application No. PCT/US09/42635;

WHEREAS, we, MICHAEL A. DELLAVECCHIA and LARRY DONOSO are desirous of assigning to the PHILADELPHIA RETINA ENDOWMENT FUND our entire right, title and interest in and to the invention, all improvements to the invention, and any patents or applications therefore which have been or may be applied for, or have issued or may issue in connection with such invention or improvements thereof; and

WHEREAS, PHILADELPHIA RETINA ENDOWMENT FUND, a corporation organized and existing under the laws of the Commonwealth of Pennsylvania and having an office and place of business at 9601 Milnor Street, Philadelphia, Pennsylvania 19114, is desirous of acquiring the entire right, title and interest in and to the invention and all improvements thereon which may be made, conceived or acquired by us during the course of our association with PHILADELPHIA RETINA ENDOWMENT FUND aforesaid and for one year thereafter, in and

throughout the United States, its territories and all countries foreign thereto, and in and to said application for Letters Patent and in and to any and all Letters Patent of the United States and all countries foreign thereto which have been granted or may be granted on said invention or any part thereof, or any improvements thereon.

NOW, THEREFORE, IN CONSIDERATION of the sum of One Dollar (\$1.00), and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, and intending to be legally bound hereby, We, MICHAEL A. DELLAVECCHIA, and LARRY DONOSO, by these presents do hereby sell, assign and transfer unto the said PHILADELPHIA RETINA ENDOWMENT FUND our entire right, title and interest in and throughout the United States, its territories and all countries foreign thereto in and to said invention and any improvements thereon which may be made, conceived or acquired by us during the course of our association with the said PHILADELPHIA RETINA ENDOWMENT FUND, and for one year thereafter, in and to said applications for Letters Patent and any and all Letters Patent and extensions thereof, of the United States and countries foreign thereto which have been or may be granted on said invention or any part thereof, or improvements thereon or on said application, or any divisional, continuing, renewal, reissue, or other application and all international priority rights associated therewith, based in whole or in part thereon, or based upon said invention, or any improvements thereon;

TO BE HELD AND ENJOYED by the said PHILADELPHIA RETINA ENDOWMENT FUND, and its legal representatives and assigns to the full ends of

the terms for which said Letters Patent, or any of them, have granted as fully and entirely as the same would have been held and enjoyed by us had no sale and assignment of said interest been made; and we do hereby authorize and request the Commissioner of Patents and Trademarks to issue any and all Letters Patent which may be granted upon the said application above referred to, or any of them, or upon said invention or any part thereof, or upon any improvements thereon which may be made, conceived or acquired by us during the course of our association with the PHILADELPHIA RETINA ENDOWMENT FUND and for one year thereafter, to the PHILADELPHIA RETINA ENDOWMENT FUND; and we hereby agree for ourselves, our heirs, executors and administrators, to execute without further consideration, any further legal documents and any further assignments and any releases, reissues, renewals or other application for Letters Patent that may be deemed necessary by the Assignees herein named, fully to secure to the said Assignees their interest as aforesaid in and to said invention or any part thereof or any improvements thereon, and in and to said several Letters Patent, or any of them.

We do hereby covenant for ourselves and our legal representatives, and agree with the PHILADELPHIA RETINA ENDOWMENT FUND, and its legal representatives, that we have granted no license to make or sell the said invention, that prior to the execution of this deed our right, title and interest in the said invention has not been encumbered, that we then had good right and title in and to the invention and that we have not executed and will not execute any instrument in conflict therewith.
