ASSIGNMENT OF PATENT RIGHTS

NOW, THEREFORE, in consideration of the mutual promises contained herein and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, pursuant to this Assignment of Patent Rights and subject to the Purchase Agreement, ASSIGNOR hereby assigns, transfers, and conveys to ASSIGNEE, its permitted successors and assigns, all of ASSIGNOR'S right, title, and interest in and to the patents and patent applications listed in *Exhibit A*, and (a) all foreign and U.S. counterpart patents and patent applications claiming priority from the patents and patent applications listed in *Exhibit A*, and (b) all continuations, continuations-in-part, divisionals, reissues, and reexaminations (including equivalent type extensions in non-U.S. jurisdictions) that may issue from and claim priority to the foregoing (hereinafter collectively referred to as the "Sold Patents"), and including the right to own and prosecute in ASSIGNEE'S own name any reexaminations, reissues, interferences, and all causes of action now in existence or arising in the future resulting from acts of infringement of the Sold Patents before or after the date of this Assignment, including, without limitation, the right to sue and recover for past, present, and future infringement of any of the Sold Patents.

ASSIGNOR authorizes and requests the Director of Patents and Trademarks of the United States of America and the empowered officials of all other governments to issue or transfer all said Letters Patents to ASSIGNEE, as ASSIGNEE of the entire right, title, and interest therein or otherwise as ASSIGNEE may direct.
