
ASSIGNMENT

WHEREAS, WE, MATHIEU LION and LUCAS BIGNON, citizens of France, residing at 9 Cite Aubry, Paris, France 75020 and 60 Rue Etienne Dolet, Cachan, France 94230, have invented a new and useful SPATULA, for which design application papers for United States Letters Patent are being filed herewith; and
