INTELLECTUAL PROPERTY ASSIGNMENT

This Intellectual Property Assignment (the "Assignment") is made and entered into effective as of May 1, 2009 (the "Effective Date"), by and between STEVEN CHRISTIAN, an individual residing in Houston, Texas ("Christian"), MICHAEL MAIZE, an individual residing in Houston, Texas ("Maize"), GARY DOMINY, an individual residing in Houston, Texas ("Dominy"), JAMES BETTIS, JR., an individual residing in Houston, Texas ("Bettis"), and TABLE JACKS, LLC, a Texas limited liability company ("Table Jacks") (Christian, Maize, Dominy, Bettis shall collectively be referred to as the "Members" and the Members, together with Table Jacks, shall collectively be referred to as the "Parties").

RECITALS

WHEREAS, the Members desire to assign to Table Jacks their entire right, title and interest, if any, in and to the intellectual property described herein, and Table Jacks desires to accept such right, title and interest;

NOW, THEREFORE, for and in consideration of the foregoing and the respective representations, warranties, covenants, agreements and conditions set forth herein, the parties agree as follows:

1. Assignment.

(a) Christian hereby sells, assigns and transfers to Table Jacks his entire right, title, and interest in and to the intellectual property identified in Exhibit "A" attached hereto and incorporated herein by reference (the "Christian Intellectual Property"), together with all goodwill associated with such intellectual property.

(b) Maize hereby sells, assigns and transfers to Table Jacks his entire right, title, and interest in and to the intellectual property identified in Exhibit "B" attached hereto and incorporated herein by reference (the "Maize Intellectual Property"), together with all goodwill associated with such intellectual property.

(c) Dominy hereby sells, assigns and transfers to Table Jacks his entire right, title, and interest in and to the intellectual property identified in Exhibit "C" attached hereto and incorporated herein by reference (the "Dominy Intellectual Property"), together with all goodwill associated with such intellectual property.

(d) Maize hereby sells, assigns and transfers to Table Jacks his entire right, title, and interest in and to the intellectual property identified in Exhibit "D" attached hereto and incorporated herein by reference (the "Bettis Intellectual Property", and together with the Christian Intellectual Property, the Maize Intellectual Property and the Dominy Intellectual Property, the "Intellectual Property"), together with all goodwill associated with such intellectual property.

2. Further Assurances. Each of the Members hereby covenants that he shall, at the cost and expense of Table Jacks, take all actions and execute all documents necessary or desirable to establish inventorship, to perfect the interest of Table Jacks in and to the Intellectual Property, or to substantively prosecute or enforce the Intellectual Property, including but not limited to

working with Table Jacks's counsel to prepare, review, execute, assign, and prosecute any and all patent, trademark, or copyright applications or other lawful papers included in the Intellectual Property and all related documentation, and do all lawful acts requisite for enforcing rights thereunder, and shall not enter into any agreement in conflict with this Assignment.

3. Acknowledgement. Each of the Members hereby authorizes Table Jacks to make application for and to receive patents, trademarks, and copyrights for the Intellectual Property in any country throughout the world in Table Jacks's name, at Table Jacks's election. Each of the Members hereby authorizes and requests that the competent authorities record this Assignment, and grant and issue any and all patents, trademarks, or copyrights included in the Intellectual Property to Table Jacks as the assignee of all right, title and interest therein.

4. Representations and Warranties. Each of the Members, severally but not jointly, represents and warrants that:

(a) They have ownership of all of the Christian Intellectual Property, Maize Intellectual Property, Dominy Intellectual Property or Bettis Intellectual Property, as applicable, free and clear of all liens or other encumbrances.

(b) The Christian Intellectual Property represents all interests in any intellectual property related to the business of Table Jacks ever held by Christian.

(c) The Maize Intellectual Property represents all interests in any intellectual property related to the business of Table Jacks ever held by Maize.

(d) The Dominy Intellectual Property represents all interests in any intellectual property related to the business of Table Jacks ever held by Dominy.

(e) The Bettis Intellectual Property represents all interests in any intellectual property related to the business of Table Jacks ever held by Bettis.

(f) None of the Members currently owns, nor has any applied for, any intellectual property related to business of Table Jacks, other than that covered by this Assignment. None of the Members is subject to any agreement with any third party that requires him to assign any interest in any intellectual property related to the business of Table Jacks.

5. Successors. This Assignment shall be binding upon and inure to the benefit of the Parties hereto and their respective successors and assigns.


6. Severability. If, for any reason, a court of competent jurisdiction finds any provision of this Assignment, or any portion hereof, to be unenforceable, such decision shall not affect the validity of the remaining portion, which remaining portion shall continue in full force and effect as if this Assignment had been executed with the invalid portion thereof eliminated therefrom. In the event that a portion of this Assignment shall be declared to be invalid, then the parties agree that they shall enter into good faith negotiations with one another to replace such invalid provision with a valid provision as similar as possible to that which had been held to be invalid.

7. Counterparts. This Assignment may be executed in two or more counterparts, each of which shall be deemed to be an original but all of which together shall constitute one and the same instrument.

8. Choice of law. This Assignment shall be governed by, and construed in accordance with, the internal law of the State of Texas, excluding its choice of law principles.


