**ASSIGNMENT**

**WHEREAS, WE, Youhe Zhang, Yuelin Shen, Madapusi K. Keshavan, and Mike Azar,** residing at 11703 Hillsgate Court, Tomball, Texas 77377; 2110 Brundage Drive, Apt. 4616, Houston, Texas 77090; 19 Betony Place, The Woodlands, Texas 77382; and 223 Wisteria Walk Circle, The Woodlands, Texas 77382, respectively, have invented certain new and useful improvements disclosed in an application for United States Letters Patent entitled THERMALLY STABLE POLYCRYSTALLINE DIAMOND CUTTING ELEMENTS AND BITS INCORPORATING THE SAME, Application No. 11/350,620, Filed February 8, 2006 and executed by us on even date herewith, together with claim to the priority of United States Provisional Application No. 60/651,341, filed February 8, 2005;

**AND WE HEREBY** covenant that we have full right to convey the entire interest herein assigned, and that we have not executed, and will not execute, any agreement in conflict herewith;

**AND WE HEREBY** further covenant and agree that we will communicate to ASSIGNEE any facts known to us respecting said improvements, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuation, substitute and reissue applications, make all rightful oaths and generally do everything possible to aid ASSIGNEE to obtain and enforce proper patent protection for said improvements in all countries.
