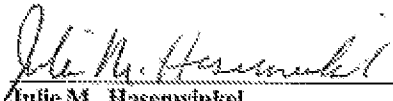
ASSIGNMENT

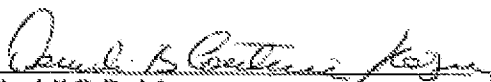
