and enjoyed by me had no sale and assignment of said interest been made;

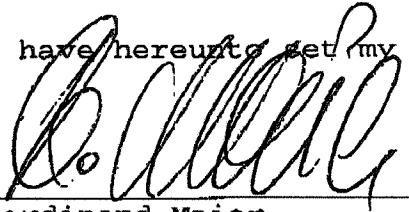

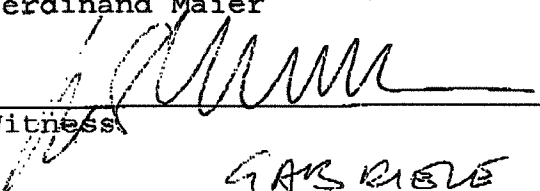
