
## ASSIGNMENT

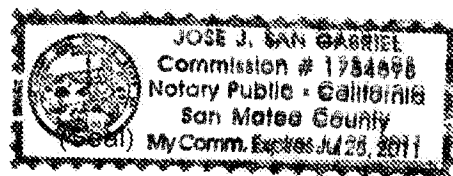
