AND be it known that the Assignor authorizes and empowers the Assignee and the Assignee's successors, assigns and legal representatives or nominees, to invoke and claim for any applications for patent or other form of protection for the Inventions filed by the Assignee, and/or by the Assignee's successors, assigns and legal representatives or nominees, the benefit of the right of priority provided by the International Convention for the Protection of Industrial Property, also known as the Paris Convention, as amended, or by any Convention which may henceforth be substituted for it and to invoke and claim such right of priority in relation to the Inventions without further written or oral authorization from the Assignor, and the Assignor hereby assigns to the Assignee any and all right it may have to claim such priority in any country;



AND the Assignor hereby covenants and agrees to do all such things and to execute without further consideration such further lawful documents, assurances, applications and other instruments as may reasonably be required to obtain Letters Patent for the Inventions and to vest the same in the Assignee and the Assignee's successors and assigns.


