ASSIGNMENT

The said Assignor hereby covenants that he has full right to convey the entire interest herein assigned and that no assignment, sale, agreement or encumbrance has been or will be entered into which would conflict with this assignment; and

The said Assignor hereby covenants and agrees that the said Assignor will sign all papers and documents, take all lawful oaths, and do all acts necessary or required to be done for the procurement, maintenance, enforcement and defense of Letters Patent or Patents for said improvements, without further consideration from said Assignee, but at the cost and expense of the said Assignee; and

The said Assignor hereby requests the Director of the U.S. Patent and Trademark Office, and any officials of foreign countries whose duty it is to issue patents on applications as aforesaid, to issue said Letters Patent to said Assignee.
