ASSIGNMENT

WHEREAS, WE, **STEPHEN DOERR**, a citizen of the United States of America residing at 10909 Cortez Court, Frisco, TX 75034, **GARY I. applications as aforesaid, to issue all Letters Patent for said improvements to said ASSIGNEE, its successors, legal representatives and assigns, in accordance with the terms of this instrument.

We HEREBY covenant that we have full right to convey the entire interest herein assigned, and that we have not executed, and will not execute, any agreement in conflict herewith.

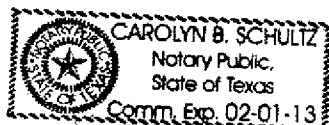
