## ASSIGNMENT

WHEREAS, WE, MATHIEU LION, residing at 9 Cite Aubry, 75020, Paris, France, and JEROME de KERAUTEM, residing at 46 rue Gigant 44100, Nantes, France, both citizens of France, have invented a new and useful design for BARBECUE PICK for which application papers for United States Letters Patent are being filed herewith; and
