**ASSIGNMENT OF INVENTION AND
PATENTS THEREON**

WHEREAS, Ranajit Chakraborty, having a residence at 2450 Oak Hill Circle, Apt. 2212, Fort Worth, in the State of Texas, 76109, has invented GENETIC MARKERS OF FOOD ALLERGY as fully disclosed in an application for Patent Serial No. 60/492,507 filed August 5, 2003; PCT/US04/25370 filed August 5, 2004; and Serial No. 10/566,903 filed October 16, 2006; preparatory to obtaining Letters Patent of the United States.

NOW, THEREFORE, TO ALL WHOM IT MAY CONCERN: Be it known that for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Ranajit Chakraborty hereby sells, assigns, transfers and sets over unto the University Of Cincinnati his entire right, title and interest in and to said Letters Patent, and in and to the subject matter disclosed therein, and any continuations, divisions, renewals, substitutes or reissues thereof, and in and to all Letters Patent, Domestic and Foreign, issued or to be obtained thereon, including all rights and interests with priority rights under the Paris Convention for the Protection of Industrial Property, the International Patent Cooperative Union, European Patent Convention, Common Market Convention, or any other Convention or Union for each country of said Convention or Union, the same to be held and enjoyed by the University Of Cincinnati, to the end of the term or terms for which said Letters Patent are or may be granted or reissued as fully and entirely as the same would have been held by RANAJIT CHAKRABORTY, had said sale, transfer and assignment not been made; together with all claims for damages by reason of past infringement of said Letters Patent, with a right to sue for, and collect same for its own use and behalf, and for the use and behalf of its successors, assigns or other legal representatives; and RANAJIT CHAKRABORTY hereby ratifies and confirms in all respects the aforesaid sale, transfer and assignment of said inventions, said applications for Letters Patent and said Letters Patent to the University Of Cincinnati.
