ASSIGNMENT

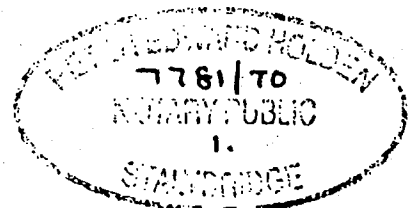

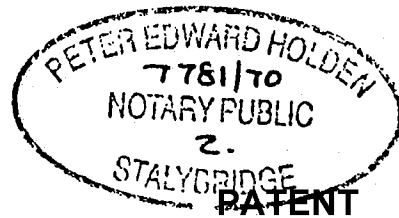
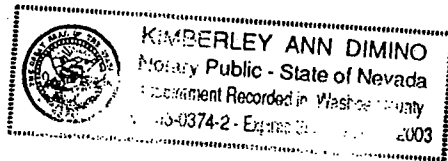
