Assignment of Patents

Seller further grants to Buyer, its successors and assigns, the right to claim for any of said patents the full benefits and priority rights of any international agreement between the United States and any foreign country or between any other countries, to the full extent of the term for which a patent may be granted therefore, together with the inventions described in the Patents, as fully and entirely as the same would have been held by Seller had this assignment not been made. Seller further grants to Buyer, its successors and assigns, Seller's entire right, title and interest in and to any and all claims and demands it may have, at law or in equity, for past infringement of the Patents.

This Assignment of Patents is made pursuant to the "Stock Purchase Agreement" between Appleton Papers Inc. and Nex Performance Films Inc., dated as of July 2, 2010.
