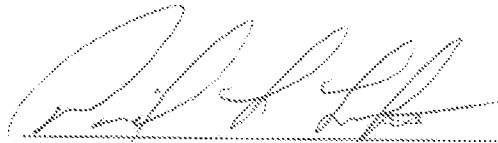

known to him, and testify as to the same in any interference or other litigation, when requested to do so.

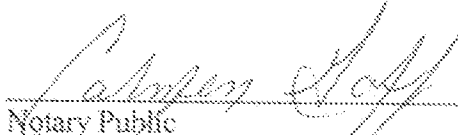

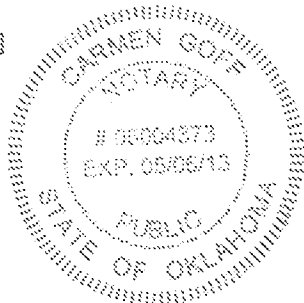

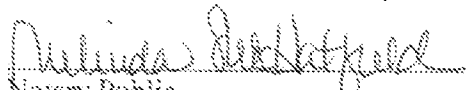
