Assignor authorizes Assignee to file patent applications in any and all countries on any or all of the Assigned Patents and Patent Applications or Inventions in Assignee's name, or otherwise as Assignee may deem advisable, under International Conventions or otherwise.

Assignor authorizes the Commissioner of Patents and Trademarks of the United States, and

under International Conventions or otherwise.
