**ASSIGNMENT OF INVENTION AND LETTERS PATENT**

WHEREAS, we, **Juan Antonio Gonzalez Leon, Gilles Barreto, Vincent Luca and Eric Jorda**, hereinafter referred to as the assignors have invented certain new and useful improvements in **ADDITIVE MIX FOR ASPHALT MIXTURE PREPARATION, USSN 12/830,741**, filed **07/06/2010** (Atty. Docket No. FR-AM2643NP) for which an application for Letters Patent of the United States has been duly executed by each of us on even date herewith.



And we do hereby request and authorize the Commissioner of Patents, U.S.A., to issue said Letters Patent when granted, in accordance with this assignment.


We further covenant and agree with the assignee that we have a full and unencumbered title to the invention herein assigned, which title we warrant unto the assignee, and we further agree that we will, without demanding any further consideration therefore, at the request but at the expense of the assignee, do all lawful and just acts, including the execution and acknowledgment of instruments,






