INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT, dated as of June 28, 2006, by and between AstraZeneca UK Limited, an English limited company (the "Seller"), and Abraxis BioScience, Inc., a Delaware Corporation ("Buyer").

WHEREAS, Seller and Buyer have entered into an Asset Purchase Agreement, dated as of April 26, 2006 (the "Purchase Agreement"; capitalized terms used and not defined herein are used as defined in the Purchase Agreement), pursuant to which Seller agreed to sell to Buyer and Buyer agreed to purchase from Seller the Transferred Assets, all as more particularly set forth in the Purchase Agreement; and

WHEREAS, the execution and delivery of this instrument by the parties is a condition to the obligations of Buyer and Seller to consummate the transactions contemplated by the Purchase Agreement;

NOW, THEREFORE, for adequate and appropriate consideration, the receipt and sufficiency of which is hereby acknowledged, and pursuant to the Purchase Agreement, the parties hereby agree as follows:

1. Transfer of Intellectual Property. Seller hereby sells, assigns, conveys and transfers to Buyer, for Buyer's sole and exclusive use and enjoyment, all of Seller's right, title and interest in and to the Transferred Intellectual Property, including:

- (a) the Transferred Patent Rights, including the patents and patent applications set forth on Schedule A attached hereto; and
- (b) the Transferred Trademarks, including the trademark registrations and applications set forth on Schedule B attached hereto (together with the goodwill attached to and symbolized by the Transferred Trademarks).

2. Delivery of Files. Seller shall, as promptly as possible after the date hereof, deliver or caused to be delivered to Buyer or Buyer's designee, all original documents and copies of records, certificates, prosecution files and other documents related solely to the Transferred Intellectual Property.

3. Issuance of Registrations. Seller hereby authorizes and requests the Commissioner of Patents and Trademarks of the United States, Register of Copyrights of the United States and any official of any state or foreign country whose duty it is to issue intellectual property registrations, to issue all registrations from any applications for registration included in the Transferred Intellectual Property to Buyer.

4. Recordation. If Buyer elects to record this assignment or any other document or transfer with the U.S. Patent & Trademark Office, U.S. Copyright Office or applicable state or foreign governmental or international authorities or registries, Buyer shall bear all costs and fees associated with such recording.

5. Further Assurances. Seller hereby covenants and agrees that, at any time and from time to time after the date of this Intellectual Property Assignment Agreement, at Buyer's request, Seller will do, execute, acknowledge and deliver, or will cause to be done, executed, acknowledged and delivered, any and all further acts, conveyances, transfers, assignments, and assurances as necessary to grant, sell, convey, assign, transfer, set over to or vest in Buyer any of the Transferred Intellectual Property.

6. Governing Law. This instrument shall be construed in accordance with and governed by the laws of the State of New York, without giving effect to the conflicts of law principles thereof.

7. Counterparts. This instrument may be executed by facsimile signature and in one or more counterparts, each of which shall for all purposes be deemed to be an original and all of which shall constitute the same instrument.

8. Headings. The headings contained in this instrument are for reference purposes only and shall not affect in any way the meaning or interpretation of this instrument.

9. Purchase Agreement Controls. The provisions of this instrument are subject to the terms and conditions of the Purchase Agreement. To the extent that any provision of this instrument is inconsistent with the Purchase Agreement, the provisions of the Purchase Agreement will control.
