

## INTELLECTUAL PROPERTY SECURITY AGREEMENT

This INTELLECTUAL PROPERTY SECURITY AGREEMENT is entered into as of June 25, 2010 by and between SILICON VALLEY BANK ("Bank") and ADEPT MOBILEROBOTS LLC ("Grantor") pursuant to that certain Unconditional Guaranty and Security Agreement (the "Unconditional Guaranty"), dated as of May 1, 2009 among Adept Technology International, Ltd., Adept Technologies Holdings, Inc., Adept Technology Canada Holding Co., and Adept Technology Canada Co. and Bank, and pursuant to that certain Loan and Security Agreement by and between Bank and Adept Technology, Inc. ("Parent") dated May 1, 2009 (as the same may be amended, modified or supplemented from time to time, the "Loan Agreement"; capitalized terms used herein are used as defined in the Loan Agreement).

### RECITALS

A. Contemporaneous herewith, Grantor is providing that certain Assumption Agreement to Bank, pursuant to which Grantor is becoming a Guarantor under that certain Unconditional Guaranty.

B. Pursuant to the terms of the Assumption Agreement and the Unconditional Guaranty, Grantor has granted to Bank a security interest in all of Grantor's right, title and interest, whether presently existing or hereafter acquired, in, to and under all of the Collateral.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, and intending to be legally bound, as collateral security for the prompt and complete payment when due of its obligations under the Loan Agreement and the Unconditional Guaranty, Grantor hereby represents, warrants, covenants and agrees as follows:

### AGREEMENT

To secure its obligations under the Unconditional Guaranty, Grantor grants and pledges to Bank a security interest in all of Grantor's right, title and interest in, to and under all of its copyright rights, copyright applications, copyright registrations and like protections in each work of authorship and derivative work, whether published or unpublished (including, without limitation, the items listed on Exhibit A), any patents, patent applications and like protections (including, without limitation, the items listed on Exhibit B), including improvements, divisions, continuations, renewals, reissues, extensions, and continuations-in-part of the same, trademarks, service marks and, to the extent permitted under applicable law, any applications therefor, whether registered or not (including, without limitation, the items listed on Exhibit C), and the goodwill of the business of Grantor connected with and symbolized thereby, know-how, operating manuals, trade secret rights, rights to unpatented inventions, and any claims for damage by way of any past, present, or future infringement of any of the foregoing, including, without limitation, all proceeds thereof (such as, by way of example but not by way of limitation, license royalties and proceeds of infringement suits), the right to sue for past, present and future infringements, and all rights corresponding thereto throughout the world (collectively, the "Intellectual Property Collateral").

This security interest is granted in conjunction with the security interest granted to Bank under the Unconditional Guaranty. The rights and remedies of Bank with respect to the security interest granted hereby are in addition to those set forth in the Loan Agreement, the Unconditional Guaranty, and the other Loan Documents, and those which are now or hereafter available to Bank as a matter of law or equity. Each right, power and remedy of Bank provided for herein or in the Loan Agreement, the Unconditional Guaranty, or any of the other Loan Documents, or now or hereafter existing at law or in equity shall be cumulative and concurrent and shall be in addition to every right, power or remedy provided for herein and the exercise by Bank of any one or more of the rights, powers or remedies provided for in this Intellectual Property Security Agreement, the Loan Agreement, the Unconditional Guaranty, or any of the other Loan Documents, or now or hereafter existing at law or in equity, shall not preclude the simultaneous or later exercise by any person, including Bank, of any or all other rights, powers or remedies.

This Intellectual Property Security Agreement may be executed in multiple counterparts; each of which shall be deemed an original, and counterpart signature pages may be assembled to form a single original document.
