PATENT ASSIGNMENT

NOW, THEREFORE, in consideration of the sum of one dollar (\$1.00) or equivalent and other good and valuable consideration paid to her, the receipt and adequacy of which is hereby acknowledged, Assignor hereby sells, assigns, transfers and conveys to the Company Assignor’s entire right, title and interest for all countries, in and to certain inventions relating to the absorbing medical compression binder, as described in the Provisional Patent Application, No. 61/135,228 and the Non-Provisional Patent Application dated May 27, 2009, and in and to said application, and all divisions, renewals and continuations thereof, and all Letters Patent of the United States which may be granted thereon, and all reissues and extensions thereof, and all applications for Letters Patent or other grants of protection of proprietary rights, including, but not limited to, inventor’s certificate, utility, model, utility certificate, patent of importation, registration of patent and industrial design registration which may be filed, and which may be granted, upon said inventions in any countries or regions foreign to the United States, and all reissues, renewals and extensions thereof; and I hereby authorize and request the Commissioner for Patents and Trademarks of the United States, and all officials of countries or regions foreign to the United States having authority so to do, to issue all such Letters Patent or other grants of protection upon said inventions to the Company or to such nominees as it may designate.

Assignor hereby authorizes and empowers the Company or nominees to invoke and claim for any application for such Letters Patent or other grants of protection for said inventions filed by it or them, the benefit of the right of priority provided by the International Convention for the Protection of Industrial Property, as amended, or by a convention which may henceforth be substituted for it, and to invoke and claim such right of priority without further written or oral authorization from Assignor.

Assignor hereby consents that a copy of this Patent Assignment shall be deemed a full and formal equivalent of any assignment, consent to file or like document which may be required in any country or region for any purpose and more particularly in proof of the right of the Company or nominees to claim the aforesaid benefit of the right of priority provided by the International Convention for the Protection of Industrial Property, as amended, or by any convention which may henceforth be substituted for it.

Assignor hereby covenants that Assignor has the full right to convey the entire right, title and interest herein assigned and that Assignor has not executed and will not execute any agreement in conflict herewith.

Assignor hereby covenants and agrees that Assignor will communicate to the Company or nominees all facts known to Assignor pertaining to said inventions and testify in all legal proceedings, sign all lawful papers, execute all divisional, continuing and reissue applications, make all rightful oaths and declarations and in general perform all lawful acts necessary or proper to aid the Company or nominees in obtaining, maintaining and enforcing all lawful patent or other grants of protection of said inventions in any and all countries and regions.
