AUTHORIZE AND REQUEST the issuing authority to issue any and all United States patents granted on said application to the Assignee;



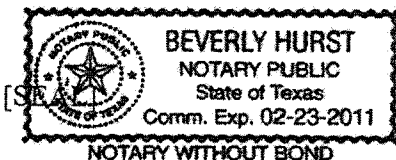
