ASSIGNORS hereby authorize and request the Commissioner of Patents to issue any and all Letters Patent of the United States on said inventions, or resulting from said application, and from any and all divisions and continuations thereof to the said ASSIGNEE, of the undivided interest, and hereby covenants that they have full right to convey their undivided interest therein assigned, and that they have not executed and will not execute any agreement in conflict therewith.


