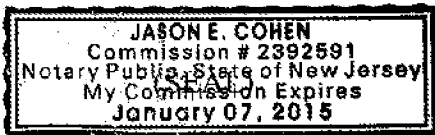
treaties, statutes, or regulations; said foreign applications to be filed and issued in the name of **Comverge, Inc.** or its designee insofar as permitted by applicable law;
