U.S. PATENTS RELEASE

U.S. PATENTS RELEASE dated as of July 28, 2010 by JPMORGAN CHASE BANK, N.A., as administrative agent (in such capacity, the "*Administrative Agent*") for the Secured Parties (as defined below).

A. Reference is made to (i) the Grant of Security Interest in Trademark and Patent Rights (the "*IP Security Agreement*"), effective as of December 19, 2008 by Brunswick Corporation, a Delaware corporation (the "*Company*"), and the subsidiaries of the Company party thereto (together with the Company, the "*Grantors*") in favor of the Administrative Agent and (ii) the Pledge and Security Agreement dated as of December 19, 2008, as amended and restated as of August 11, 2009 (together with the IP Security Agreement, the "*Security Agreements*"), by and between the Company, the subsidiaries of the Company party thereto and the Administrative Agent. Pursuant to the Security Agreements, the Grantors granted a security interest to the Administrative Agent, for the benefit of certain secured parties (the "*Secured Parties*"), in certain collateral, including the patents set forth on Schedule I hereto (the "*Patents*"), which security interest was recorded with the United States Patent and Trademark Office on January 7, 2009 at Reel/Frame 022092/0365.

B. The Grantors have informed the Administrative Agent of their desire to obtain the release of all right, title and interest of the Administrative Agent and the Secured Parties in and to the Patents.

Accordingly, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby terminates, releases and discharges its security interest in the Patents, and all right, title and interest of the Administrative Agent in such Patents shall hereby cease and be void. For the avoidance of doubt, this U.S. Patents Release does not terminate, release or discharge the Administrative Agent's security interest in any patent not listed on Schedule I hereto.

This U.S. Patents Release shall be governed by and construed in accordance with the law of the State of New York and shall be binding upon the Administrative Agent's representatives, successors, assigns and transferees.
