**ASSIGNMENT DEED**

**WHEREAS**, Stacy M. Kemp, a citizen of the United Kingdom who resides at 849 N. Franklin St. #416, Chicago, Illinois 60610 ("INVENTOR"), has made the inventions described in the patent application listed in Schedule A (the listed patent application hereinafter referred to as "PATENT APPLICATION" and the associated inventions hereinafter referred to as "INVENTIONS");

**WHEREAS**, Accenture Services Limited, a United Kingdom corporation, of 60 Queen Victoria Street, London EC4N 4TW, United Kingdom, ("ASSIGNOR") has acquired the rights of the INVENTOR to the INVENTIONS and the PATENT APPLICATION listed in Schedule A through operation of United Kingdom law applicable to employees who have invented in the regular course of their employment;

**WHEREAS**, pursuant to these arrangements ASSIGNEE desires to acquire the ASSIGNOR's entire right, title and interest in and to said INVENTIONS AND PATENT APPLICATION, and in and to any Letters Patent or Patents obtained therefore or thereon in the United States or in any other country, including the interest of the INVENTOR transferred to the ASSIGNOR by operation of United Kingdom law;

**NOW, THEREFORE**, said ASSIGNOR with full title guarantee hereby assigns, transfers, and sets over unto the ASSIGNEE, its successors, legal representatives and assigns, the entirety of the ASSIGNOR's right, title and interest in and to the INVENTIONS AND PATENT APPLICATION, and in and to any other applications that may later be filed on the inventions anywhere else in the world, and in and to any and all divisions, continuations and continuations-in-part of any such application, or reissues, reexaminations or extensions of said Letters Patent or Patents, and the full right to claim for any such applications all benefits and priority rights under any applicable convention, treaty or legislation, and the right to sue and obtain relief, including damages, profits and an injunction, for any past, present or future infringement occurring before or after issuance of said Letters Patent or Patents, the same to be held and enjoyed by said ASSIGNEE, for its own use and the use of its successors, legal representatives and assigns, to the full end of the term or terms for which Letters Patent or Patents may be granted, as fully


and entirely as the same would have been held and enjoyed by the ASSIGNOR had this Assignment not been made;


