NUNC PRO TUNC PATENT ASSIGNMENT

WHEREAS, Hayes Lemmerz International—Laredo, Inc., a subsidiary of each of HLI OPERATING COMPANY, INC., a Delaware corporation and HAYES LEMMERZ INTERNATIONAL, INC., a Delaware corporation, both having offices at 15300 Centennial Drive, Northville, MI 48168, USA (“Assignor”) entered into an Asset Purchase Agreement with Harvey Holdings, LLC, a Michigan limited liability company having offices at 1021 Manufacturers Drive, Westland, MI 48186, USA (“Assignee”);

WHEREAS, in a Patent Assignment dated January 6, 2010 and in accordance with the Asset Purchase Agreement, Assignor previously sold, conveyed, transferred, assigned, and delivered unto Assignee, its successors and assigns, all right, title and interest in and to the applications relating to and the underlying invention described in an Unfiled Invention Disclosure entitled “EGR Mixer for Lower Intake Manifold”;

WHEREAS, it has come to Assignee’s attention that the above-referenced Unfiled Invention Disclosure corresponds to U.S. Patent Application Serial No. 12/582,078, filed on October 20, 2009, entitled “Mixer for Use in an Exhaust Gas Recirculation System and Method for Assembly of the Same” (“the Application”);

WHEREAS, Assignor and Assignee wish to ratify and confirm the assignment and transfer of the entire right, title and interest in and to any and all rights and privileges regarding the patents and patent applications set forth in the Patent Assignment, including the Application; and

NOW THEREFORE, in consideration of the promises and covenants contained herein and in the Asset Purchase Agreement and the Patent Assignment and for other good and valuable consideration, the parties agree as follows:

1. ASSIGNMENT OF RIGHTS.

Assignor hereby sells, conveys, transfers, assigns and delivers unto Assignee, its successors and assigns, Assignor’s entire worldwide right, title, and interest in and the Application, the underlying invention described in the Application, the right to file foreign patent applications corresponding to the Application, and the right to claim the priority date of the Application and any legal equivalents thereof, and any and all patents in the United States of America and all foreign countries which may be granted therefore and thereon, and to any and all divisions, continuations, and continuations-in-part of the Application, or expansions, re-issues, renewals or extends of any and all patents which may be granted therefore and thereon, including the right to sue for past infringements thereof;

2. FURTHER ASSISTANCE.

Assignor hereby covenants and agrees that Assignor will, at any time during the 12 months following the date hereof and upon the written request of the Assignee, execute and deliver any and all papers and do all lawful acts reasonably necessary to perfect the rights, titles, and interests conveyed to Assignee herein and Assignee’s successors and assigns and to permit Assignee and Assignee’s successors and assigns to record this Agreement against the Application with any government office; provided, however, that nothing herein shall obligate Assignor to obtain any signatures, papers or other acts from any inventor no longer employed by the Assignor or its affiliates.

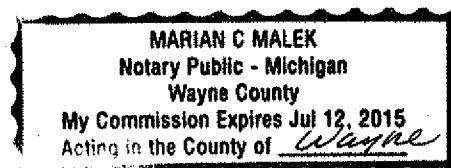
