ASSIGNMENT

WHEREAS, WE, NANCY LACROIX-TOYNE, RAFFI MEKHITARIAN, DIKRAN BABIKIAN, JACOBUS MARCUS BERKHOUT, ROBERT RICCOMINI, WILLIAM CONWAY, AND PETER HUES, residing at 6634 Valmont Street, Tujunga, California 91042; 9600 Wheatland Avenue, Shadow Hills, California 91040; 1748 Hillcrest Avenue, Glendale, California 91202; 1341 Hoover Street, Menlo Park, California 94025; 20180 Orchard Meadow Drive, Saratoga, California 95070; 11233 Shadyridge Drive, Moorpark, California 93021; and 6112 Via De Las Abejas, San Jose, California 95120, respectively, have invented certain new and useful improvements disclosed in an application for United States Letters Patent entitled **VENDING APPARATUS AND METHOD**, filed July 1, 2010, Application No. 12/829,366, together with claim to the priority of United States Provisional Application No. 61/270,071, filed July 1, 2009 and United States Provisional Application No. 61/270,432, filed July 7, 2009.
