## PATENT SECURITY AGREEMENT

Patent Security Agreement (this "Agreement") dated as of July 1, 2010 by and between Multimedia Commerce Group, Inc., a Tennessee corporation (the "Grantor"), having its chief executive office at 10001 Kingston Pike, Knoxville, Tennessee 37922, and WELLS FARGO BANK, NATIONAL ASSOCIATION (successor by merger to Wachovia Bank, National Association), as Administrative Agent (the "Administrative Agent"), with offices at 123 South Broad Street, PA 1246, Philadelphia, Pennsylvania 19109, for the ratable benefit of the banks and other financial institutions (the "Lenders") from time to time parties to the Amended and Restate Credit Agreement, dated as September 9, 2008, (as amended, restated, supplemented or otherwise modified, the "Credit Agreement") by and among Grantor, America's Collectibles Network, Inc. ("ACN") (ACN and Grantor together, the "Borrowers"), the Lenders and the Administrative Agent.

This Agreement is executed pursuant to the terms of a Collateral Agreement dated as of September 9, 2008 by and among the Borrowers, certain of their Subsidiaries party thereto and the Administrative Agent (as amended, restated, supplemented or otherwise modified, the "Collateral Agreement"). Capitalized terms used herein but not defined herein shall have the meaning assigned to them in the Collateral Agreement.

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged, the Grantor hereby grants to the Administrative Agent, a continuing security interest in all of the Grantor's right, title and interest in, to and under the following, whether presently existing or hereafter arising or acquired:

- (i) each Patent and Patent application of the Grantor, including, without limitation, each Patent and Patent application described on Schedule A;
- (ii) each Patent License, including, without limitation, each Patent License described on Schedule B;
- (iii) all claims by the Grantor against third parties for (a) past, present or future infringement of any Patent or Patent application, including, without limitation, any Patent or Patent application listed on Schedule A or under any Patent License, including, without limitation, any Patent License described on Schedule B, or (b) breach or enforcement of any Patent License; and
  - (iv) all products and proceeds of the foregoing.

The rights and remedies of the Administrative Agent with respect to the security interest granted herein are without prejudice to, and are in addition to those set forth in the Collateral Agreement, all terms and provisions of which are incorporated herein by reference. In the event that any provisions of this Agreement are deemed to conflict with the Collateral Agreement, the provisions of the Collateral Agreement shall govern.
