ASSIGNMENT OF INVENTION

This assignment (this "Assignment") is made as of August 20, 2009 (the "Effective Date") by Wilhelm C. Fischer, an individual of Berkeley Heights, New Jersey, United States ("ASSIGNOR") in favor of Zenko Technologies, Inc., a corporation created and existing under the laws of Delaware, having a place of business at 647 Bound Brook Road, Middlesex, New Jersey 08846 ("ASSIGNEE").

WHEREAS, ASSIGNOR is the inventor, jointly with Yusuke Ota, an individual of Mountain Lakes, New Jersey, United States, of the invention entitled "Optical fiber unit having automatic shutdown" (the "Invention") that is found in U.S. patent application serial number 12/583,433 (the "Patent Application"), which was filed on August 20, 2009; and

(b) the Patent Application, and any letters patent that may issue thereon, any continuation, division, renewal, or substitute thereof, and letters patent or any reissue or reexamination thereof, and any legal equivalent thereof in a foreign country;

together with all other rights relating to (a) and (b) above, including, without limitation, damages and payments for past or future infringements and misappropriations thereof, and all rights to sue for past, present and future infringements or misappropriations thereof.

2. ASSIGNOR hereby covenants that no assignment, sale, agreement or encumbrance has been or will be made or entered into which would conflict with this Assignment.

3. ASSIGNOR further covenants that ASSIGNEE will, upon its request, be provided promptly with all pertinent facts and documents relating to the Invention and the Patent Application and legal equivalents as may be known and accessible to ASSIGNOR and will testify as to the same in any interference, litigation, or proceeding related thereto and will promptly execute and deliver to ASSIGNEE or its legal representatives any and all papers, instruments or affidavits reasonably requested to apply for, obtain, maintain, issue, and enforce rights in such Invention and such Patent Application and any equivalents thereof which may be necessary or desirable to carry out the purposes thereof.
