FOURTH: The Corporation is authorized to issue 110,000 shares of capital stock, consisting of 15,000 shares of Class A Voting Common Stock, without par value, and 95,000 shares of Class B Nonvoting Common Stock, without par value. The holders of Class A Voting Common Stock shall have the right to one vote per share for the election of directors and all other matters upon which the shareholders of the Corporation are entitled to vote. The holders of Class B Nonvoting Common Stock, except as required by the mandatory provisions of Ohio law, shall have no voting rights.
