

**ASSIGNMENT**

WHEREAS, I, Douglas D. Kaspar (ASSIGNOR), am the inventor of the invention entitled ELECTROCOAGULATION REACTOR HAVING SEGMENTED INTERMEDIATE UNCHARGED PLATES, for which I filed an application for a patent of the United States on May 26, 2010, assigned Serial No. 12/787,715; and
