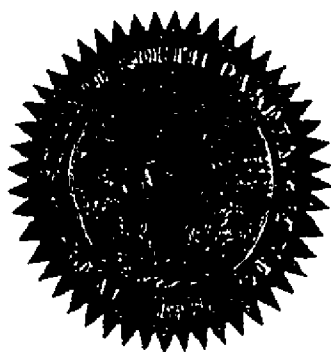


### CERTIFICATE OF AMENDMENT

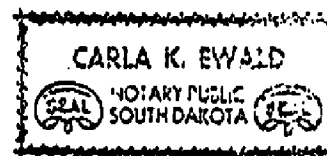
