**ASSIGNMENT***UTILITY PATENT*

**WHEREAS**, the undersigned inventors (hereinafter singly and collectively, "ASSIGNORS"), of the addresses indicated below, have invented certain new and useful improvements in **"ANTIPERSPIRANT PRODUCTS COMPRISING ACTIVE ANTIPERSPIRANT COMPOUNDS SURFACE TREATED WITH HYDROPHOBIZING AGENTS AND METHODS FOR MANUFACTURING THE SAME"**, for which application for a Non-Provisional Patent of the United States was executed as of the dates written below by ASSIGNORS;
