## ASSIGNMENT

WHEREAS, we, Heather Gornik of Cleveland, County of Cuyahoga and State of Ohio, John R. Penn and Jonathan Schaffer, and do hereby assign, sell and set over unto the said CCF, its successors or assigns, the entire right, title and interest in and to the said improvements and any and all inventions pertaining thereto, said application, all patents granted therefore in the United States of America and elsewhere, and the right to apply for patents therefore in all countries foreign to the United States and to claim for such applications the priority of United States applications, and we hereby request the Commissioner of Patents of the United States, and any official of any country or countries foreign to the United States whose duty it is to issue patents, to issue such patents to the said CCF, its successors or assigns; and we further agree to execute such other applications and other instruments and do all other acts as may be deemed necessary by the said CCF, its successors or assigns in order to fully secure, protect and preserve its rights to the said improvements and to obtain patents therefor in the United States of America and all countries foreign to the United States, all without further consideration but at the expense of the said CCF, its successors or assigns.


