## ASSIGNMENT

WHEREAS, the UNIFORMED SERVICES UNIVERSITY OF THE HEALTH SCIENCES, a United States Government Agency (hereinafter referred to as Assignor), by virtue of an assignment from an inventor executed on May 18, 2004, has right, title, and interest in an invention entitled:

which was filed at the United States Patent and Trademark Office as a Provisional Patent Application on August 8, 2000 (Serial No. 60/223,734), now abandoned in lieu of International Patent Application PCT/US01/19089, filed June 12, 2001; and

WHEREAS, the HENRY M. 
