TERMINATION OF INTELLECTUAL PROPERTY SECURITY AGREEMENT


WHEREAS, NewRiver, Inc., a Massachusetts corporation, located at 200 Brickstone Square, 5th Floor, Andover, Massachusetts 01810 (the "Grantor") and Silicon Valley Bank dba Silicon Valley East, a California-chartered bank, located at 3003 Tasman Drive, Santa Clara, California 95054 (the "Lender"), entered into a certain Intellectual Property Security Agreement (the "Security Agreement"), dated as of December 22, 2003, which was recorded in the United States Patent and Trademark Office on December 31, 2003 at Reel 014227 and Frame 0261 for patents and which was recorded in the United States Patent and Trademark Office on December 31, 2003 at Reel 2771 and Frame 0881 for trademarks, that by its terms granted the Lender a security interest in certain intellectual property listed in Exhibit B (the "Patents") and in Exhibit C (the "Trademarks") to the Security Agreement and all trademark applications, patent applications, patents and trademark registrations acquired or arising after the date of the Agreement;

WHEREAS, the Grantor has or has caused to be paid and satisfied in full the obligations for which the security interest in the Patents and Trademarks was granted.

NOW THEREFORE the Lender hereby reassigns to the Grantor the interest in the Patents and Trademarks listed on Schedule A and Schedule B attached hereto in which Lender was granted a security interest under the Security Agreement. The Lender also hereby releases its security interest in the Patents and Trademarks listed in Schedule A and Schedule B attached hereto. The Lender further agrees, for itself, its successors and assigns, to execute such further documents and to perform such further lawful acts as may reasonably be requested by the Grantor, to effectuate this termination.

IN WITNESS WHEREOF the parties hereto by the signature below of their duly authorized representatives agree to be bound by the provisions of this Termination as of the date of execution, this 18th day of August, 2010.
