**ASSIGNMENT AGREEMENT**

The Assignor hereby confirms that she has sold, assigned and transferred and does hereby sell, assign and transfer unto the Assignee, the full and exclusive right to the Patent in the United States, and the entire right, title and interest in and to any applications claiming priority therefrom or the benefit thereof, and any related divisionals, continuations, continuations-in-part, reissues and extensions of such Patent in the United States and all other countries.
2. The Assignor hereby agrees that she will, without further consideration, do all such things and execute all such documents as may be necessary or desirable to obtain and maintain the Patent, any applications claiming priority therefrom or the benefit thereof, and any related divisionals, continuations, continuations-in-part, reissues and extensions of such Patent, and for additions and modifications thereto in any and all countries, and to vest title thereto in the Assignee, their successors, assigns and legal representatives or nominees.
3. The Assignor hereby authorizes and requests the Commissioner of Patents and Trademarks of the United States of America and any official of any country or countries foreign to the United States whose duty it is to issue patents and any other aforementioned applications, to issue any said patents to the Assignee of the entire right, title and interest in and to the same, for their sole use and benefit, and for the use and benefit of their successors and assigns, to the full end of the term for which the Patent may be granted as fully and entirely as the same would have been held by the Assignors had this assignment and sale not been made.


