## ASSIGNMENT OF PATENT

And for the same consideration, Assignor transfers and assigns to assignee all damages for past infringements of the Patent.

Assignor covenants that it has the full right to convey the entire interest assigned, and that it has not executed, and will not execute, any agreement in conflict with this assignment.

Assignor further covenants and agrees that it will communicate to Assignee any facts known to it respecting the Patent and testify in any legal proceeding, sign all lawful papers, execute all reissue applications, make all rightful oaths and generally do everything possible to aid Assignee to obtain and enforce proper patent protection for the improvements in all countries.

This assignment is effective January 1, 2005.
