

ASSIGNMENT

WHEREAS, PelleTech Fuels, Inc., a corporation with a place of business at 313 Bloody Pond Road, P.O. Box 9, Lake George, NY 12845 (hereinafter "Assignor"), has invented certain new and useful improvements in "Fuel Pellet and Method of Making the Fuel Pellet" which are described in U.S. patent number #5,643,342 issued July 1, 1997; U.S. patent number #5,980,595 issued November 9, 1999; and Canadian patent number #2,228,497 issued March 11, 2003 (hereinafter "Intellectual Property").

WHEREAS, PelletShield Engineered Products, LLC, a limited liability company with a place of business at 20 Godfrey Drive, Orono, ME 04473-3610 (hereinafter "Assignee"), is desirous of acquiring the entire right, title, and interest in said Intellectual Property;

NOW THEREFORE, in consideration of two thousand seven hundred and fifty dollars (\$2,750.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Assignor hereby grants and assigns to said Assignee, its entire right, title, and interest for the United States and its territorial possessions and in all foreign countries, in and to, said Intellectual Property, related or derivative patents and any and all inventions and improvements which are disclosed therein or may be derived therefrom and any legal equivalents thereof in any foreign country; including but not limited to the right to file, prosecute, and claim priority from said Intellectual Property; and the right, in and to, all patents, letters patents or foreign legal equivalents as may be obtained for said Intellectual Property by the above patents or any continuation, division, continuation-in-part, extension or substitute thereof, and any reissue, reexamination or extension of said Intellectual Property or letters patents and all foreign legal equivalents; as well as all rights under all International Conventions for the Protection of Industrial Property related thereto; and the right to bring actions for infringement of any right in said Intellectual Property in Assignee's own name, including past infringement, in any jurisdiction.

The Assignor hereby authorizes and requests the United States Commissioner of Patents and Trademarks and all corresponding foreign officers to issue to said Assignee, its successors, assigns, and legal representatives, as owner of the entire interest in accordance with this Assignment, said Intellectual Property, including any and all patents, letters patents, or foreign equivalents to the full end of the term for which they may be granted and as fully and entirely as the same would have been held by Assignor had this Assignment not been executed.

The Assignor hereby warrants and covenants that no assignment, sale, mortgage, license or other agreement or encumbrance has been or will be made or entered into by Assignor which does or would conflict with this Assignment and that the Assignor has the full right to convey the rights and property as herein expressed.

The Assignor hereby further covenants that the Assignor will without further consideration and without expense to Assignee, sign all lawful papers and perform all other lawful acts which the Assignee may request to make this Assignment fully effective, including

but not limited to, promptly executing and delivering to Assignee or its legal representative any and all papers, instruments or affidavits required to apply for, obtain, maintain, issue, or enforce said applications, said patents or letters patents, and said foreign equivalents thereof which may be necessary or desirable to carry out the purposes thereof. The Assignor further covenants that it will, upon Assignee's request, promptly provide all pertinent facts and documents, as may be known and accessible to the Assignor, relating to said Intellectual Property, and that the Assignor will, additionally, testify as to the same, at the request of the Assignee, in any interference, litigation, or proceeding relating thereto.

This Assignment and the promises of this agreement herein shall be binding upon the Assignor, its heirs, successors, assignees and legal representatives.


