TERMINATION OF PATENTS SECURITY AGREEMENT

WHEREAS, NewRiver, Inc., a Massachusetts corporation, located at 200 Brickstone Square, 5th Floor, Andover, Massachusetts 01810 (the "Company") and Fleet National Bank, n/k/a Bank of America, N.A., located at 100 Federal Street, Boston, Massachusetts 02110 (the "Bank"), entered into a certain Security Agreement (Patents) (the "Security Agreement"), dated as of May 29, 2001, which was recorded in the United States Patent and Trademark Office on July 3, 2001 at Reel 011934 and Frame 0504, that by its terms granted the Bank a security interest in certain intellectual property listed in Schedule A (the "Patents") to the Security Agreement and all patent applications and patents acquired or arising after the date of the Agreement;
