Caywood**, 12816 West Lake Road, Vermillion, Ohio 44089, **(7) Joseph John Janos**, 905 Wall Road, Wadsworth, Ohio 44281, **(8) John Joseph Ascherl**, 3438 E. Smith Road, Medina, Ohio 44256, **(9) Rex Young**, Lou-Tien 3rd Industry Zone, Long Jing Rd,#518105 Song-Gang Bao-An Dist, Shen Zhen, Guang Dong Province, China (hereinafter referred to as "INVENTORS"), and **The L.D. Kichler Co.**, an Ohio corporation with its principal place of business at 7711 E. Pleasant Valley Road, Cleveland, Ohio 44131-5552 (hereinafter referred to as "KICHLER").

whole or in part upon said inventions or upon said applications, and any and all Letters Patent and reissues and extension of Letters Patent granted for said inventions or upon said applications, and every priority right that is or may be predicated upon or arise from said inventions, said applications and said Letters Patent.

2. KICHLER is hereby authorized to file patent applications in any or all countries on any or all said inventions in the name of the INVENTORS or in the name of KICHLER or otherwise as KICHLER may deem advisable, under the International Convention or otherwise.



6. INVENTORS agree that this Assignment shall be construed in accordance with the laws and courts of Ohio. INVENTORS hereby also agree to submit to the jurisdiction of any Ohio court.
