**ASSIGNMENT**

WHEREAS John Sheblak and Tim Little (hereinafter ASSIGNORS) have invented a certain improvement in 2D IMPOSTERS FOR SIMPLIFYING PROCESSING OF PLURAL ANIMATION OBJECTS IN COMPUTER GRAPHICS GENERATION for which a so-entitled patent application for Letters Patent of the United States was filed in the United States Patent and Trademark Office on June 14, 2010 under Application No. 12/814,949 (Attorney Docket 723-2775).

And, ASSIGNORS hereby agree to transfer a like interest upon request of said ASSIGNEE, its successors, assigns, and legal representatives, and without further remuneration, in and to any improvements, and applications for patents based thereon, growing out of or related to the said invention; and to execute any papers by ASSIGNEE, its successors, assigns, and legal representatives, deemed essential to ASSIGNEE's full protection and title in and to the invention hereby transferred.

ASSIGNORS agree further upon request of ASSIGNEE, and without further remuneration, to execute any and all papers desired by ASSIGNEE, for the filing and granting of regular and foreign applications and the perfecting of title thereto in ASSIGNEE.
