ASSIGNMENT

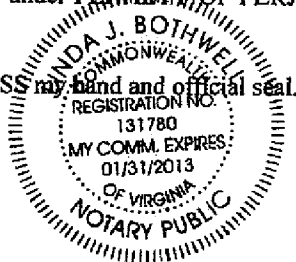



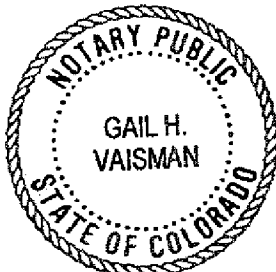
